Control Costs

Leasing provides peace of mind related to a private fleet's finances. A fullservice lease can give companies a better handle on the actual month-tomonth costs associated with a vehicle and minimize the volatile costs that come with ownership. Without a lease, maintenance costs can create a large unknown for private fleets, but leasing eliminates the question marks since the lease and maintenance payment is flat.



Plus, Penske's MyFleet application provides detailed insight into each leased unit's running costs. The app breaks out costs for each unit, which gives users a general overview of the vehicles, as well as specific costs by

unit number and location. This allows a fleet manager to focus on units that have a higher operating cost to determine the root cause, such as driver behavior.

Decrease Operational Risks

The primary goal of operations is to fulfill the obligations to the customer, which means equipment uptime is crucial. Missing a pickup or delivery due to a breakdown or lack of equipment is not an option. If a truck fails, it could irritate the customer, which could result in lost business. Penske not only researches equipment prior to its release, but in some cases has also been involved in the production process.


For private fleets considering a new technology, such as automatic transmissions, leasing can provide an opportunity for drivers to try it before the fleet manager commits to it.

Routine preventive maintenance can improve safety, prevent breakdowns and minimize costly repairs down the road. Properly maintained vehicles avoid violations at roadside inspections, which helps private fleets improve



their scores within the Federal Motor Carrier Safety Administration's Compliance, Safety, Accountability program.


Rental Leasing Logistics Having a third party manage maintenance also reduces the liability an on-site maintenance facility carries with it, such as labor and environmental requirements.
