If you already have a CT Registration Number and need to register for the Highway Use Fee account, create a myconneCT username and add a new account. When should I register?

If you already have a Connecticut Tax Registration number, please use **myconneCT** to manage your accounts.

If you do not have a Connecticut Tax Registration number, use this service to register for the following business account types with the Connecticut Department of Revenue Services:

What do I need to register?

In order to complete this business tax registration, you will need:

The Federal Employer Identification Number (FEIN) of the business or the Social Security Number (SSN) of the sole proprietor. If your business does not have an FEIN (and you are not a sole proprietor), you need to apply for an FEIN with the IRS. [Apply for an FEIN.](#)

The legal name of the business or the sole-proprietor's name

The business name (DBA), if applicable

The business address

Banking information to pay permit/license fees (if applicable) **The application fees once submitted are not refundable.**

The names and Social Security Numbers of responsible owners/officers

Note: If you would like to save this REG-1 application and will return to complete it at a later time, select the 'Save Draft' button. Your application will be saved for 30 business days.

Please note

If you need to register for any of these account types and you are not registered with DRS, you must first complete the electronic REG-1 process on **myconneCT** to obtain a Connecticut Tax Registration Number.

You must complete a paper **REG-1 Addendum E**, as applicable, and mail the completed Addendum to DRS. If you are currently registered with DRS and just need to add one of the account types below, then just complete the applicable addendum and mail it to DRS.
